Dear Mr. Geerhart:

This letter responds to your recent Freedom of Information Act ("FOIA") request received by the Federal Communications Commission (FCC or Commission) and assigned to the Consumer & Governmental Affairs ("CGB") and Enforcement ("EB") Bureaus. You are requesting "copies of all FCC complaints that have been submitted regarding FOX NEWS CHANNEL" for the past three years. We are responding to your request electronically.

CGB conducted a search of the databases in which we maintain the records of informal complaints filed by, or on behalf of, consumers. Our search revealed approximately 365 complaints that are responsive to your request, which are attached. EB informed CGB that a search of its records identified no responsive records.

The FCC receives many complaints and comments that do not involve violations of the Communications Act or any FCC rule or order. Thus, a complaint or comment does not necessarily indicate any wrongdoing by any individuals or entities named in the complaint or comment. The attached complaints represents information provided by the public that has not been verified by the FCC.

Record responsive to your request were withheld or redacted under FOIA Exemption 6.¹ Exemption 6 protects files containing personally identifiable information disclosure of which would constitute a clearly unwarranted invasion of personal privacy. Balancing the public's right to disclosure against the individual's right to privacy, we have determined that release of this information would constitute a clearly unwarranted invasion of personal privacy. Therefore, all FCC employee's names, complainant's addresses, and the complainant's telephone numbers were redacted under Exemption 6

FOIA and FCC rules require the FCC to charge requesters for time spent searching for and reviewing responsive documents, and for copying them.” Pursuant to section 0.466(a)(5)-(7) of the Commission’s rules, you have been classified as category (2), “educational requesters, non-commercial scientific organizations, or representatives of the news media.”² As an “educational requester, non-commercial scientific organization, or representative of the news media,” the Commission assesses charges to recover the cost of reproducing the records requested, excluding the cost of reproducing the first 100 pages. The production in response to your request is electronic, and did not involve any duplication. Therefore, you will not be charged any fees.

If you consider this to be a denial of your FOIA request, you may seek review by filing an application for review with the Office of General Counsel. An application for review must be *received* by the Commission within 90 calendar days of the date of this letter.³ You may file an application for review by mailing the application to Federal Communications Commission, Office of General Counsel, 445 12th St SW, Washington, DC 20554, or you may file your application for review electronically by e-mailing it to FOIA-Appeal@fcc.gov. Please caption the envelope (or subject line, if via e-mail) and the application itself as “Review of Freedom of Information Action” and the application should refer to FOIA No. 2017-587.

A young, enthusiastic female AT&T manager is explaining the benefits of using AT&T in their workplace.</p> <p>My complaint is in regard to the obvious bias against the lone man in the commercial, which uses every non-verbal opportunity to portray him as a hapless and weak individual. The women, on the other hand, are all self-satisfied, hard-nosed deal makers. Why the simpering man is included is not clear, unless your sole purpose is to emphasize that this male co-worker is not on a par with these women who know exactly what they want and how to get it. He?s barely part of the group as he remains half-hidden in his non-prominent place and simply imitates the reactions of the women at the commercial?s conclusion. It is pitiful and offensive.</p> <p>Your organization is not alone in this concerted effort to portray men, especially white men, as weak and ineffective. You must not realize that this ad is interpreted negatively by viewers as it continues to run daily and at prime time. LIMBAUGH: So our last caller from Des Plaines, Illinois, wanted to know, ?What is the politics in the coverage of the suicide of Robin Williams?? Well, I believe there is some. But I don?t think that the politics is driving it. I think there was, on the part of media and Hollywood, genuine affection for the guy that is driving it, but there is politics. If you notice the coverage is focused on how much he had, but it wasn?t enough.

?He had everything, everything that you would think would make you happy. But it didn?t. ? Now, what is the left?s worldview in general? What is it? If you had to attach not a philosophy but an attitude to a leftist worldview, it?s one of pessimism and darkness, sadness. They?re never happy, are they? They?re always angry about something. No matter what they get, they?re always angry.

They are animated in large part by the false promises of America, because the promises of America are not for everyone, as we see each and every day. I mean, right here there?s a story Fox News website. Do you know, it says right here, that the real reasons that Robin Williams killed himself are he was embarrassed at having to take television roles after a sterling movie career.

He had to take movie roles that were beneath him, sequels and so forth, and he finally had to do television just to get a paycheck because he was in so much financial distress. He?d had some divorces that ripped up his net worth, and he had a big ranch in Napa that he couldn?t afford any longer and had to put up for sale, and a house in Tiburon that he couldn?t afford anymore. This is all what?s in the Fox News story.

He had it all, but he had nothing. He made everybody else laugh but was miserable inside. I mean, it fits a certain picture, or a certain image that the left has. Talk about low expectations and general unhappiness and so forth. Right here it says that one the contributing factors to Robin Williams deciding to kill himself was ?survivor?s guilt.? It?s in the headline.

I read that and I thought, ?Survivor?s guilt? What? What survivor?s guilt? What?? So I

read it, and it turns out that three of his closest friends, the story says ? Christopher Reeve, John Belushi, and Andy Kaufman? The source, unnamed in the story, said that Robin Williams felt guilty that he was still alive while his three friends had died young and much earlier than he had.

He could never get over the guilt that they died and he didn't.

Well, that is a constant measurement that is made by political leftists in judging the country. It's outcome-based education: 2 + 2 = 5. ?That's fine until the student learns it's 4. We're not gonna humiliate the student by pointing out that he's wrong. If he figures it out, cool. We're gonna take the fast learners and we're gonna slow them down so that they don't humiliate the kids that don't learn as fast as they do. It's just not fair.?

I think a person has to be deeply troubled to find politics in the death of Robin Williams. The degree of detachment from reality that it takes to make such a statement is why Limbaugh's comments are worth discussing. There is a school of thought on the left that Limbaugh should be ignored. These are folks who suffer from ostrich syndrome. They want to stick their heads in the sand and pretend like what they disagree with doesn't exist. This desire is a manifestation of the fact that a segment of the left is becoming just like the right. There are people who only want their media to stay on the left side of the partisan fence.

The problem with that mentality is that it allows individuals to ignore the threat that is presented by the ideology on overdrive right. Millions of people listen to Limbaugh. They share his beliefs. These are folks who drive the Republican Party. If one wants to understand and defeat the extremism of the right, it is necessary to know what they are talking about, and why.

There is no leftward ideology that pushed Robin Williams to take his own life. Limbaugh was exploiting a man's personal pain and tragedy to push an ideological agenda. Ignoring Rush Limbaugh, or Fox News, or the Republicans in Congress won't make that agenda go away. Limbaugh's attempt to use the death of Robin Williams was a window into right-wing thinking. The politics never stops, and everything is political for many on the right.

Ignoring Rush Limbaugh won't make him go away. He has hundreds of stations carrying his program around the country, but ignoring his words would allow him to operate in a zero accountability environment. Rush Limbaugh should not be able to make deplorable remarks like those that he made about the death of Robin Williams without being held accountable.

For the individuals and families of those that he demonizes and exploits, we must hold Rush Limbaugh accountable.

Trump supporters and others took to Twitter, calling the joke homophobic.

As the backlash swelled, Colbert's camp was silent. A "Late Show" spokeswoman and the comedian's agent did not respond to requests for comment, and Colbert did not address the controversy on Tuesday's show — or on his Twitter feed.

But Wednesday night, he opened his show by discussing the now-infamous joke.

"While I would do it again, I would change a few words that were cruder than they needed to be," he said. "I'm not going to repeat the phrase. But I just want to say, for the record, life is short, and anyone who expresses their love in their own way, is to me an American hero. I think we can all agree on that.

"I hope even the president and I can agree on that. Nothing else. But, that."

Colbert's monologues have largely focused on Trump, his aides and their gaffes. And his lampooning of the president seems to have paid off.

Just last year, he was trailing far behind Jimmy Fallon's "The Tonight Show." Colbert managed to narrow down Fallon's lead and eventually topped his competition. By late March, Colbert's show was averaging nearly 3 million viewers, about 400,000 more than Fallon's.

But as The Washington Post's Callum Borchers wrote, by joking about oral sex, Colbert "rushed the bro-ternity" of Alex Jones, who once said that Rep. Adam B. Schiff (D-Calif.) "looks like the archetypal c—sucker," and Jesse Watters, who came under fire for a not-so-subtle joke about Ivanka Trump "speaking into that microphone."

Sitting on a panel on "The Fox News Specialists" on Tuesday, Karl Rove, who was a senior adviser in the administration of former president George W. Bush, called the jokes "lewd," "obscene" and "inappropriate."

"They wrote this. This was not a rant that he came up with on the top of this head. They wrote this," Rove said, adding later: "I'm going to continue to do what I do with anything Colbert. I'm going to refuse to watch the SOB."

Many demanded an apology.

Others hijacked the trending hashtag with sarcastic jabs at Colbert's critics:

Colbert began his scathing monologue Monday night by making fun of Trump's comments about the first 100 days in office, which the president called a "ridiculous standard."

"Trump has repeatedly said that this 100 days is totally arbitrary, okay. Totally unimportant. And to prove how unimportant it is, he took out a TV ad, he cut a cake on Air Force One, and he held a rally in Pennsylvania," Colbert said. "The theme of that rally, 'Promises Made, Promises Kept.' Which is better than the original slogan, 'Promises made, never mind, never said it, fake news, watch Fox & Friends.' "

He then turned to how Trump abruptly ended the interview with Dickerson, after the "Face the Nation" host asked him if he stands by his claims that President Barack Obama had wiretapped him.

Trump's response to the question was replayed on Colbert's show:

"I don't stand by anything," Trump told Dickerson.

That's when Colbert said: "It's true. He doesn't stand by anything except the dressing room door at Miss USA Pageant. ... Who needs a lotion?"

But it was Trump telling Dickerson that he was a purveyor of "fake news" and calling his show "Deface the Nation" that seems to have set Colbert off.

In an interview Wednesday with Newsmax TV, Federal Communications Commission Chairman Ajit Pai said the agency does not get into the business of regulating content. The Supreme Court, he said, has placed some limits on the authority of the FCC, which regulates communications by radio, television, wire, satellite and cable.

"It's a free country. People are willing and able to say just about anything these days," Pai said, adding later that unless a content is indecent, obscene or profane by FCC standards, the agency's authority is "pretty limited."
